### Type of action:

Immediate return to CeramOptec and / or destruction of the products. Details of the components in question, which may be non-sterile:

### Description of the problem:

Due to issues with the manufacturer's third-party service provider, it is possible that „Retractor" and „Proctoscope" are not sterile. This FSN applies to the product codes and lots listed in the Appendix.

The products are included in the following kits:

FiLaC@ Fistula Kit,  
LHP@ Procedure Kit,  
HeLP@ Procedure Kit

### Instructions to the user:

1. Immediately destroy the „Retractor" and „Proctoscope" lots listed in the Appendix that are still in your possession. Destroy products with codes and batches not listed in the attachment that you still have in stock.
2. Please tell us the number of products destroyed and confirm it informally. This information is necessary so that we can monitor the progress of the action.
3. Due to the problem described above, Biolitec is currently unable to supply complete LHP kits. The part numbers of these kits are 501100220 or 503100220, depending on the laser used.




